Burn Pit Toxic Exposure

When Will All Victims Finally Get Veterans Benefits? This past year, advocates for those ill Veterans saw a number of bills to extend research, monitoring and benefits eligibility advance further than ever before in Congress, only to stall out at the end of the year. Leaders in the House and Senate have promised to keep pushing those measures along. But partially in response to that momentum, the VA has begun its own work on the issue, granting presumptive benefits to some burn pit victims for the first time. In August, VA officials announced that veterans suffering asthma, rhinitis and sinusitis who served in most overseas war zones after September 2001 would be presumed to have contracted the condition from the toxic smoke emanating from such pits. That designation reduces the paperwork and proof needed to link the conditions to individuals' time in service and speeds up the process of getting them disability payouts. Several thousand Veterans have already been approved for the new benefits. Then in November, White House officials announced a full review of how all future disability claims will be evaluated, including a 90-day review of numerous rare cancers believed linked to military burn pits. The results of that work should be made public this month.

Veterans Affairs officials have estimated more than 3.5 million troops were exposed to the toxic smoke from burn pits during overseas deployments over the past 20 years, but a full accounting of the injuries and illnesses that smoke caused has never been completed.

The Four Chaplains Memorial Service



Post 10 will hold a remembrance ceremony for the Four Chaplains on Sunday 6 February at 1300 in the Post Hall. This year marks the 79th anniversary of the sinking of the United States Army Transport Dorchester and the selfless acts of four Army chaplains aboard.

The Dorchester tragically sunk on Feb. 3, 1943, while crossing the North Atlantic, transporting troops to an American base in Greenland. A German U-boat fired a torpedo that struck the Dorchester, killing 672 of the 902 officers and enlisted men, merchant seamen and civilian workers aboard. Many of those survivors owe their lives to the courage and leadership exhibited by four chaplains of different faiths, who, in sacrificing their lives, created a unique legacy of brotherhood.

As soldiers rushed to lifeboats, Reverend **George Fox** (Methodist), Jewish Rabbi **Alexander Goode**, Reverend **Clark Poling** (Dutch Reformed) and Father **John Washington** (Roman Catholic) comforted the wounded and directed others to safety. One survivor watched the chaplains distribute life jackets, and when they ran out, they removed theirs and gave them to four young men.

As the Dorchester sank, the chaplains were seen linked arm in arm, praying.

Ms. **Shelby Morrison** from Northern Virginia Therapeutic Riding Program (NVTRP) gave a brief background about the program. NVTRP, located at O'Shaughnessy Farm, offers a wide range of programs and services to children and adults who live with disabilities in the Washington Metropolitan Area.

There is an opportunity for everyone at NVTRP, whether it is a child diagnosed with autism, cerebral palsy or Down syndrome; a young teen coping with the effects of abuse; an elderly adult who now uses a wheelchair and lives with the vestiges of polio; or a Veteran regaining life's balance while recovering from an amputation, brain injury or post-traumatic stress disorder. NVTRP helps to build and focus on individuals' abilities, rather than disabilities by providing high-quality therapeutic riding, physical therapy and occupational therapy. They also offers riding lessons and summer camp to people without disabilities through Fairfax County Park Authority.

NVTRP offers special sessions for recovering military service members and Veterans. These lessons are a mixture of therapeutic riding and equine-assisted learning and focus on the participants relationship-building with the horse, which allows for healing in many ways. Horses are non-judgmental partners who thrive on positive relationships and teamwork. Working with horses requires clear, confident communication; a calm, focused intention; and being physically active and outdoors. All of these are essential to helping recovering military service members and Veterans adapt to the world out of service or home with family again. Other benefits of NVTRP are the warm, welcoming staff and volunteers and the tranquil nature of the environment which helps these individuals continue to return to this new situation and create bonds with humans as well as horses.

Our military servicemen and women work long hours and spend extended periods of time away from their families in order to protect our country and others who are less fortunate around the world. The sacrifices they make while fighting for our freedom allow us to enjoy the way of life to which we've grown accustomed. In return, and with the help of our generous donors, NVTRP is able to provide equine assisted services free of charge to military participants.

Housing Related Supportive Services for Veteran Families (SSVF)

For very low-income Veterans, SSVF provides case management and supportive services to prevent the imminent loss of a Veteran's home or identify a new, more suitable housing situation for the individual and his or her family; or to rapidly re-house Veterans and their families who are homeless and might remain homeless without this assistance. The SSVF Program has been allocated \$202 million from the Coronavirus Aid, Relief, and Economic Security (CARES) Act to provide emergency housing and homelessness prevention assistance to very low-income Veteran families to mitigate the expected wave of evictions and potential homelessness that will result from extensive unemployment. Funds for this program will also assist the Housing and Urban Development (HUD)-VA Supportive Housing program in placing Veterans in safe housing to isolate them from the virus. What is a Service Dog? According to the Americans with Disabilities Act, service dogs are specially trained to perform specific tasks for people with disabilities. These disabilities can be physical, sensory, psychiatric, intellectual, or mental. Service dogs have full public access rights, which means they can go places where other animals aren't allowed. This includes restaurants, libraries, and public transportation. There is no universally-accepted list of types of service dogs.

Which Breeds Make the Best Service Dogs? Dogs have an outstanding sense of smell that far surpasses humans. In fact, their sense of smell is 10,000 – 100,000 times better than that of people. But it takes more than a good nose to be a service dog. The breeds most commonly used as service dogs share the following key characteristics: **A desire to work.** Your service dog should be happier on a walk or at the dog park than they are laying around at home. **A calm demeanor.** Your service dog can't cause disturbances in public or be easily startled by their surroundings. **Intelligence.** Your service dog has to perform complex tasks that require innate intelligence and good decision making. **A friendly disposition.** Your service dog must be friendly and comfortable around people and other animals. **A loving disposition.** Your service dog must be able to form a strong bond to best serve your needs.

With that in mind, here are a few of the dog breeds that make the best service dogs: Labradors (American and English), Golden Retrievers, German Shepherds, Poodles, Boxers, Great Danes, Border Collies, Bernese Mountain Dogs, Pomeranians, Portuguese Water Dogs.

Types of Service Dogs: Allergy Detection Dogs, Autism Service Dogs, Diabetic Alert Dogs, Guide Dogs, Hearing Dogs, Mobility Assistance Dogs, Psychiatric Service Dogs, Seizure Alert Dogs.
