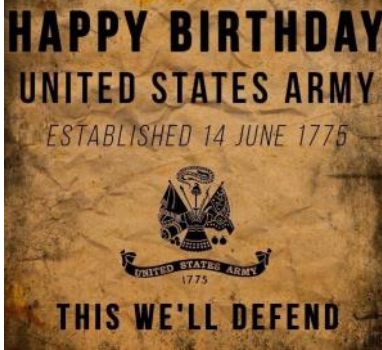

PTSD AWARENESS MONTH





HAPPY 247th BIRTHDAY, ARMY! The US Army was founded on 14 June 1775, when the Continental Congress authorized enlistment of riflemen to serve the United Colonies for one year. The 14 June date is when Congress adopted “the American continental army” after reaching a consensus position in The Committee of the Whole. This procedure and the desire for secrecy account for the sparseness of the official entries for the day. Congress undertook to raise 10 companies of riflemen, approved an enlistment for them, and appointed a committee to draft rules and regulations for the government of the army. There was a time when there were never more than 48,000 Continental soldiers. Today, the Army boasts over one million soldiers on duty which includes the Reserves and National Guard members.

Korean War: The Korean war began on June 25, 1950, when some 75,000 soldiers from the North Korean People’s Army came across the 38th parallel, the boundary between the Soviet-backed Democratic People’s Republic of Korea to the north and the pro-Western Republic of Korea to the south. This invasion was the first military action of the Cold War. By July, American troops had entered the war on South Korea’s behalf. It was a war against the forces of international communism. After some early back-and-forth across the 38th parallel, the fighting stalled and casualties mounted. American officials worked to fashion some sort of armistice with the North Koreans. The alternative, they feared, would be a wider war with Russia and China—or even, as some warned, World War III. Finally, in July 1953, the Korean War came to an end. In all, some 5 million soldiers and civilians lost their lives in what many in the U.S. refer to as **“the Forgotten War”** for the lack of attention it received compared to more well-known conflicts like World War I and II. The Korean peninsula is still divided today.

Have you wondered about the history of Flag Day?

When the American Revolution broke out in 1775, the colonists weren't fighting united under a single flag. Instead, most regiments participating in the War for Independence fought under their own flags. In June of 1775, the Second Continental Congress met in Philadelphia to create the Continental Army, a unified colonial fighting force. This led to the creation of the first "American" flag, the Continental Colors. This flag, which was comprised of 13 red and white alternating stripes and a Union Jack in the corner, was too much like that of the British flag. **George Washington** soon realized that flying a flag that was even remotely close to the British flag was not a great confidence-builder for the revolutionary effort, so he turned his efforts towards creating a new symbol of freedom.

On June 14, 1777, the Second Continental Congress took a break from writing the Articles of Confederation and passed a resolution stating that "the flag of the United States be 13 stripes, alternate red and white," and that "the union be 13 stars, white in a blue field, representing a new constellation.

In 1916, **President Wilson** marked the anniversary of that decree by officially establishing June 14 as Flag Day.

As you celebrate the anniversary of the Stars and Stripes, here are some fast facts about "Old Glory."
- **Bernard Cigrand**, a Wisconsin teacher, originated the idea for an annual flag day in 1885, to be celebrated across the country every June 14. He led his school in the first formal observance of the holiday. **Cigrand**, who later changed careers and practiced dentistry in Illinois, continued to promote his concept and advocate respect for the flag throughout his life.

- It is widely believed that **Betsy Ross**, who assisted the Revolutionary War effort by repairing uniforms and sewing tents, made and helped design the first American flag. However, there is no historical evidence that she contributed to Old Glory's creation. It was not until her grandson **William Canby** held an 1870 press conference to recount the story that the American public learned of her possible role. **And that in a nutshell is the history of Flag Day.**

If you haven't received a form from National Headquarters, send a check, and a note with your name, ID number, address, email and phone number.
3. In person. Stop by Post 10 and ask the bartender for a membership envelope, fill out the envelope, include your membership number and dues.
4. Legion dues are \$35.00 and your new 2022 membership card will be mailed to you. Please provide your address, email and phone number. It's important to be able to contact you. Your information is stored in a protected database, accessible to only the post officers with the need to know. If you have an email account, and can receive the newsletter electronically, it will save the Post money. Please feel free to email me.

Sonora Smart Dodd was an influential figure in the establishment of Father's Day. Her father raised six children by himself after the death of their mother. This was uncommon at that time, as many widowers placed their children in the care of others or married quickly. **Sonora** was inspired by the work of **Anna Jarvis**, who had pushed for Mother's Day celebrations. **Sonora** felt her dad deserved recognition for what he had done. The first time Father's Day was held in June was in 1910. Father's Day was officially recognized as a holiday in 1972 by **President Nixon**.

VA compensation and pension (C&P) exams, which are sometimes also called claim exams, are an important part of your claims process. C&P exams help VA rate your disability, which affects how much disability compensation you'll receive.

It is very important that you know that you must sign and complete a "Appointment of Veterans Service Organization as Claimant's Representative (also called "power of attorney" form). This authorizes The American Legion to assist Veterans and beneficiaries. Additionally, please send your full and complete contact information.

Corporal McMaugh, USMC, was manning Post 1 when the embassy was attacked on April 18, 1983. He lost his life along with 16 other Americans and dozens of Lebanese citizens when terrorists slammed a van with 2,000 pounds of explosives into the embassy.

The Marine Embassy Guard Association is comprised of United States Marines who have formerly served or are currently serving as Marine Security Guards since the inception of the program in 1948 and its deployment in January 1949 to U.S. Diplomatic Missions WORLDWIDE.

Have you received a suspicious call from an organization claiming to represent or have affiliation with the Department of Veteran Affairs (VA)? Did the caller guarantee a lucrative payout for your disability compensation or pension claim for a “small fee”?

If so, you may be a target of a scammer. Recently, VA has seen an increase of fraudsters and non-accredited representatives who are targeting the pension benefits of elderly Veterans and their dependents and survivors.

VA is committed to defeating fraudsters, who target elderly Veterans, by educating them, their families, and all partners about the types of fraudulent tactics being used against them, including Pension Poaching.

Pension Poaching is the financial exploitation by an advisor who profits by artificially qualifying a claimant for VA pension benefits. The scheme often involves financial maneuvers such as advising claimants to hide their assets in trusts or annuity products sometimes resulting in lost investments and lucrative fees paid to the advisor. Pension Poaching is rapidly evolving as a preferred method used by criminals to defraud elderly Veterans, survivors, and their families who are eligible for VA benefits.

To avoid being a victim to these tactics, here are some helpful tips to remember when protecting yourself from fraud:

- Be suspicious if someone offers to shift your assets around to qualify for VA pension. You may be required to repay benefits to the government.
- NEVER share eBenefits, VA.GOV, or other VA login credentials with anyone.
- DO NOT deposit VA benefits directly into a third-party bank account unless the person is court appointed or a VA accredited fiduciary.

Remember, VA does not charge for processing a claim or request a processing fee. Use VA accredited organizations to help file your claim.

VA does not threaten or take adverse actions such as jail or lawsuits on claimants. If in doubt, call VA directly at 1-800-827-1000. To report suspected activity, please contact the VA Office of Inspector General (OIG) by calling 1-800-488-8244. You may also file a complaint with the Federal Trade Commission by visiting

www.consumercomplaints.ftc.gov

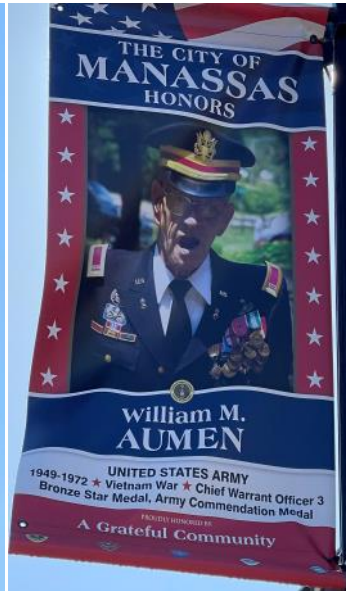

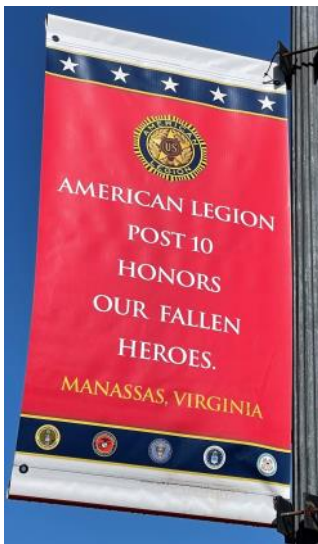
