## MEMORIAL DAY, Monday, 30 MAY 2022

### ***WHAT'S THE DIFFERENCE BETWEEN MEMORIAL DAY AND VETERANS DAY?***

On both Memorial Day and Veterans Day, it's customary to spend time remembering and honoring the countless veterans who have served the United States throughout the country's history. However, there is a distinction between the two holidays:

**Memorial Day** commemorates the men and women who **died** while in the military service of their country, particularly those who died in battle or as a result of wounds sustained in battle. In other words, the purpose of Memorial Day is to memorialize the veterans who made the **ultimate sacrifice** for their country. We spend time remembering those who lost their lives and could not come home, reflecting on their service and why we have the luxury and freedom that we enjoy today. We might consider how we can support and safeguard their grieving families and loved ones who are left behind.

**Veterans Day** is the day set aside to thank and honor ALL who served—in wartime or peacetime—regardless of whether they died or survived. Veterans Day is always observed officially on November 11, regardless of the day of the week on which it falls.

For those who have lost loved ones in the military, hearing “**Happy Memorial Day**” can be unsettling. Many veterans have expressed their displeasure with the phrase, deeming it inappropriate for the occasion. While Veterans Day is a time to honor all those who have served in the military, Memorial Day is meant to pay tribute to those military personnel who *died while serving*.

The holiday began three years after the Civil War ended and was known as Decoration Day, a time to decorate the graves of fallen soldiers with flowers. The designated date was 30 May, the Uniform Monday Holiday Act (28 JUN 1968) took effect, moving Memorial Day to the last Monday in May.

In 2015, Marine Corps veteran **Jennie Haskamp** wrote a piece for The Washington Post in which she shared her frustration with the sentiment of “Happy Memorial Day” and the holiday's transformation into “grilled meat, super-duper discounts, a day off work, beer, potato salad and porches draped in bunting.” She said it should be more than that. Others have argued that using Memorial Day as an opportunity to celebrate with loved ones and embrace the joy that life has to offer is a fitting way to honor those who died in service of our country.

Those who seek to remind people of the more somber meaning of Memorial Day have advocated for Congress to change the date of the holiday back to 30 May, instead of making it part of a three-day weekend of leisure. These efforts have not been successful, Congress established “**The National Moment of Remembrance**” in 2000, asking Americans to pause for a minute of silence and reflection in honor of those who died in military service at **3 p.m. local time on Memorial Day**.

In **Haskamp's** Washington Post piece, she noted that a friend reminded her how many people use Memorial Day to “pause and remember the men and women who paid the price of our freedom, and then go on about enjoying those freedoms.” But she believes not enough people commemorate the occasion in this way. “Not enough people pause. Not enough people remember,” she wrote, “I hope you enjoy your weekend — but I hope you pause to remember, too.”

## The POPPY and MEMORIAL DAY

In the war-torn battlefields of Europe, the common red field poppy was one of the first plants to reappear. Its seeds scattered in the wind and sat dormant in the ground, only germinating when the ground was disturbed—as it was by the very brutal fighting of World War 1.

**John McCrae**, a Canadian soldier and physician, witnessed the war first hand and was inspired to write the now-famous poem “In Flanders Fields” in 1915. He saw the poppies scattered throughout the battlefield surrounding his artillery position in Belgium.

In November 1918, days before the official end of the war, an American professor named **Moina Michael** wrote her own poem, “We Shall Keep the Faith,” which was inspired by **McCrae’s** “In Flanders Fields.” In her poem she mentioned wearing the “poppy red” to honor the dead, and with that, the tradition of adorning one’s clothing with a single red poppy in remembrance of those killed in the Great War. **Moina** became known as “The Poppy Lady.”

The wearing of the poppy was traditionally done on Memorial Day in the U.S., but the symbolism has evolved to encompass all Veterans living and deceased, so poppies may be worn on Veterans Day as well. Not long after the custom began, it was adopted by other Allied nations, including Canada, Australia, New Zealand, and the United Kingdom. In these countries, the poppy is worn on Remembrance Day (Nov. 11th).

Today, poppies are not only a symbol of loss of life, but also of recovery and new life, especially in support of the Veterans who survived the war but suffered from physical and psychological injuries long after it ended.


### “In Flanders Fields”

4. Legion dues are \$35.00 and your new 2022 membership card will be mailed to you. Please provide your address, email and phone number. It's important to be able to contact you. If you have an email account, and can receive the newsletter electronically, it will save the Post money. Please feel free to email me.

For those members who renew on line: You are able to print out a card immediately with your receipt. That is all the proof you need to show that you are a member in good standing for the new membership year. The card is valid for all purposes. I will send out a card with my name on it once I am notified by National that payment has been made.




**Victory in Europe Day (VE– Day), 8 MAY 1945**—VE Day celebrates the Allied Forces accepting the Nazi's unconditional surrender from World War II. The final document was signed on 8 May 1945. Today, countries throughout the world celebrate VE Day annually, on either 8 or 9 May. There were street parties and parades throughout the Western world - especially in the UK and the USA. The day was declared a national holiday. The war was not fully over, however, as Japan had still yet to surrender (they would on 2 September 1945). Both **Prime Minister Churchill** and **President Truman** echoed this fact in their broadcasts, citing the event as “*a victory only half won*”.

For lots of people, the day was a solemn affair. Throughout Europe, wives had lost husbands and families had been torn apart by the war. VE Day was a chance to grieve and reflect. It gave them a glimpse of a future that was not entirely governed by a global war. And for the families who were lucky enough to be reunited with loved ones, it was a day worth celebrating. New York was the site of the largest celebration within the US. Crowds gathered in Times Square and thousands marched down Fifth Avenue. Even before the official declaration NY officials knew what was coming and placed 15,293 Police Officers on duty “*to ensure that celebrants are held within the bonds of sane and reasonable hilarity.*” In Brooklyn, Queens, and the Bronx, services of prayers and thanksgiving were held at each borough hall. Jewish, Protestant, and Catholic clergy, along with Veteran organizations participated in special services. Other major celebrations occurred in San Francisco, Baltimore, and Hawaii.

*Nemo*  
*Air Force Sentry Dog, 377th Security Police*  
*Served from 1966 — 1967*

Sentry dogs are trained to warn their handlers of the approach or presence of strange persons and are utilized for guarding vital installations. Look no further than the story of *Nemo* A534 a German Shepherd who put his life on the line again and again during the Vietnam War to understand the superior instincts and sheer bravery of these remarkable service dogs.

It's 1966 and the war in Southeast Asia is raging on when the Tan Son Nhut Air Base in South Vietnam comes under attack. *Nemo*, a sentry dog with the 377th Security Police unit, catches an unfamiliar scent and alerts his handler, Airman *Robert Throneburg*. Dozens of enemy forces

have sneaked through an opening in the perimeter's barbed wire fence, scattering throughout the base. The danger is very real, but only *Nemo* along with other Sentry dogs on the base can sense it. With Airman *Throneburg* following close behind, *Nemo* races in pursuit of the intruders. *Throneburg* kills two of the enemy intruders, but not before being wounded. *Nemo*, too, fell victim to a bullet, which entered under his right eye and exited through his mouth. Though seriously injured, *Nemo* continues to attack other intruders while guarding *Throneburg* until help finally arrives.

On June 23, 1967, Air Force HQ directed that *Nemo* be returned to the U.S. with honors as the first sentry dog to be officially retired from active service. After making several publicity tours and television appearances, *Nemo* moved into his permanent kennel at Lackland Air Force Base in San Antonio, Texas, where military working dogs from all branches are trained. There, he basked in the glow of retirement (and his celeb status) until his death in December 1972 at the age of 11.

## **Disability Compensation & Benefits Available to Vietnam War Veterans**

While in the military, some Veterans may have been exposed to a variety of environmental and chemical hazards that carry potential health risks. During the Vietnam War, one such hazard was Agent Orange, a blend of herbicides sprayed from 1962 to 1971 to remove the leaves of trees and other foliage. In the years since, Veterans Administration (VA) has recognized certain cancers and diseases as presumptive diseases associated with exposure to Agent Orange during qualifying military service.

If you're a Vietnam Veteran or the eligible survivor of a Veteran with a presumptive health condition, you may be eligible for VA disability compensation. A presumptive condition is a condition VA assumes is related to a Veteran's qualifying military service. If you have an illness that is not on the list of presumptive diseases, but you believe it is connected to military exposure, you can still file a claim for VA disability benefits. However, you will need to submit more evidence to support your claim.

You can file a claim or appeal a decided claim on your own or with help from an accredited attorney, claims agent or Veterans Service Officer (VSO). These professionals are trained and certified in the VA claims and appeals processes and can help you with VA related needs. **The Electronic Health Record Modernization Program Did Not Fully Meet the Standards for a High-Quality, Reliable Schedule:** VA is replacing its aging electronic health record system with a new one intended to be interoperable with the Defense Department to give healthcare providers a continuous and comprehensive medical history for veterans. The Electronic Health Record Modernization (EHRM) program is expected to take about 10 years to implement across VA facilities, with projected completion in fiscal year 2028.

The Office of Inspector General (OIG) audited the EHRM program's master schedule as part of its continued oversight of this costly and complex effort and identified reliability weaknesses. The audit team found VA lacked a reliable integrated master schedule consistent with scheduling standards, which increases the risk of missing milestones and delaying the delivery of a system to support prompt quality care to veterans. Schedule delays that extend the program are also likely to result in about \$1.95 billion in cost overruns per year and may undermine VA's other modernization efforts on supply chain and financial management systems.

Additional deficiencies included known tasks not being reflected on schedules, no risk analysis, lack of longer-term actions scheduled, and no complete baseline schedule or overall schedule that fully integrated individual project schedules. VA also did not comply with federal regulations when it paid its contractor for deliverables before accepting them (reviewing for compliance with contract requirements).

VA concurred with the OIG recommendations for the EHRM program office to comply with internal guidance and develop an integrated master schedule that meets standards, improve stakeholder coordination to ensure activities from all relevant VA entities are included, implement procedures for performing schedule risk analyses, make contract language and program office plans or other guidance consistent, evaluate and modify contract requirements for schedule management to clarify roles for further schedule development and maintenance, and issue guidance to accept deliverables not separately priced before invoice payment.

**US Soldiers' & Airmen's Home National Cemetery:** Located just north of the Armed Forces Retirement Home in D.C. is one of the country's oldest national cemeteries. The cemetery marks the final resting place for more than 14,000 veterans, including many who fought in the Civil War. Soldiers' and Airmen's Home National Cemetery is one of two cemeteries maintained by the Department of the Army – the other being Arlington National Cemetery. During the Civil War, churches and other public buildings around D.C. were commandeered for use as military hospitals to care for wounded troops or those stricken with illness on the front lines. Just days after the Battle of Bull Run, the commissioners of the US Military Asylum offered six acres of land at the north end of the home's grounds as a burial ground for soldiers and officers. This offer was accepted in late July 1861, and the first burials were conducted later that summer. From 1861 to 1864, the cemetery accepted thousands of soldiers' remains

from across the nation, which quickly filled its six acres. An 1874 report noted more than 5,600 interments, including 278 unknown, 125 Confederate prisoners of war and 117 civilians (relatives of the deceased and employees of the home). In 1883, nine acres were added to the grounds, bringing the cemetery's size to nearly sixteen acres. In 1900, Confederate remains were reinterred in Section 16 of Arlington National Cemetery. Soldiers' and Airmen's Home National Cemetery is also the final resting place of 21 recipients of the **Medal of Honor**.
