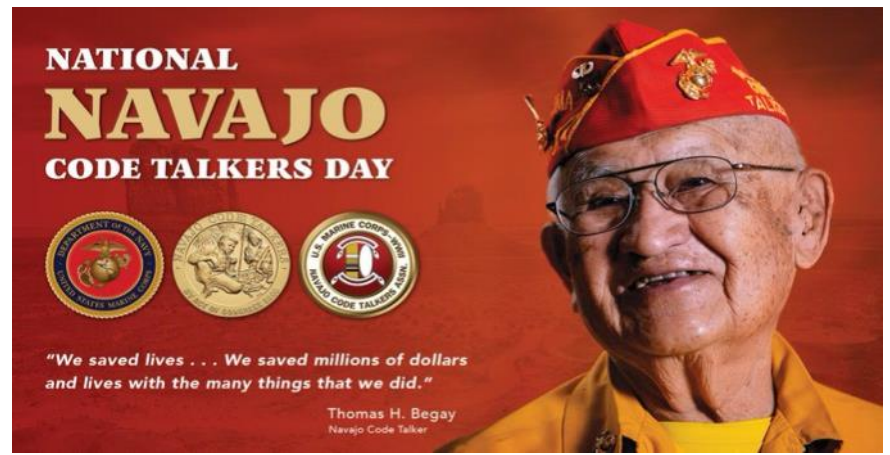
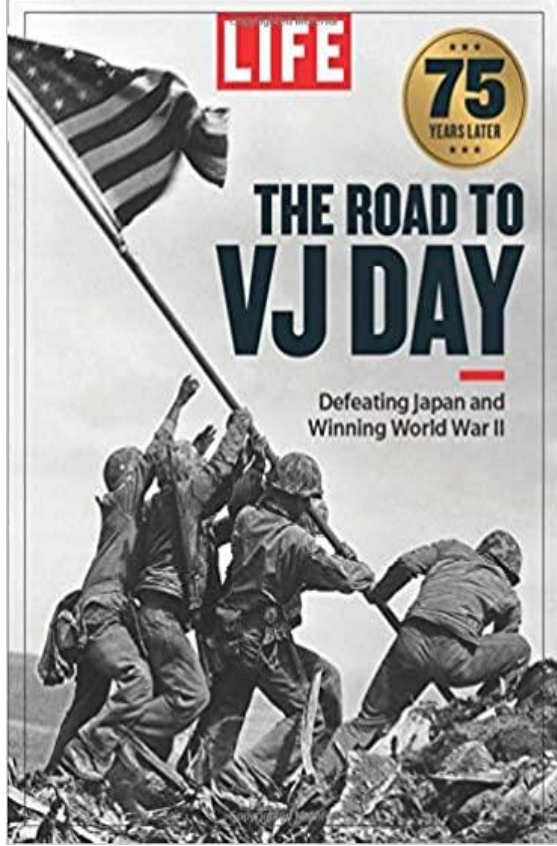

“No Parking” zones in front of important buildings; Intruders found in secure areas; A person wearing clothes that are too big and bulky and/or too hot for the weather; Chemical smells or fumes that worry you; Questions about sensitive information, such as building blueprints, security plans or VIP travel schedules without a right or need to know; Purchasing supplies or equipment that can be used to make bombs or weapons or purchasing uniforms without having the proper credentials

“If you see something, say something” is common theme when it comes to terrorism awareness, and that is being strongly emphasized in August. “Trust your instincts; if a behavior or activity makes you feel uncomfortable, REPORT IT.”

These reminders may sound familiar; they are posted in airports, train stations, bus terminals, etc. Antiterrorism Awareness Month is designed to bring these reminders back into the spotlight, serving as a reminder that we live in times which require this added watchfulness.

## **NATIONAL NAVAJO CODE TALKERS DAY**

14 August 1982: President Ronald Reagan declared this day Navajo Code Talkers Day. Native American Code Talkers were inducted into the NSA Cryptologic Hall of Honor in 2013. The official plaque presentation took place in April 2014. From [Navajocodetalkers.com](http://Navajocodetalkers.com): The story of the Navajo Code Talkers begins in 1940 when a small group of Chippewas and Oneidas became a part of the radio communications 32nd Infantry Division. Soon after, Sac and Fox tribes joined in the ranks as combat radiomen. The complexity of Navajo linguistics allowed it to become an ideal choice to be used in code due to the lack of documentation made available for learning to speak the language and ability for the same words to mean multiple things based on sound. The legacy of the Navajo Code Talkers will continue as many documentary and stories have been shared about their journey since it's declassification during Reagan's Administration.

The most common causes of disability in Veterans are injuries they received during combat, although Veterans can incur injuries throughout their military training and service. These disabilities are considered service-connected disabilities. It is very important that you know that you must sign and complete a “Appointment of Veterans Service Organization as Claimant’s Representative (also called “power of attorney” form). This authorizes The American Legion to assist Veterans and beneficiaries. Additionally, please send your full and complete contact information.

## NATIONAL SPIRIT OF '45 DAY HISTORY

In 1996, a project paired children with seniors to document their memories from World War II. Started by *Warren Hegg* and the Spirit of '45 Organization, the project grew. Soon they realized many shared a common story.

In 2009, spokesman *Ernest Borgnine* and *Edith Shain\** talked about a day honoring the World War II generation. A year later in 2010, Congress passed a joint resolution in commemoration of the 65th anniversary of the day President *Truman* announced the end of World War II.

**National Spirit of '45 Day** honors the can-do attitude of an entire generation affected by the trials and hardships of World War II. Observed every year on the second Sunday in August, communities around the country hold events and memorials. Each one honors those who have inspired us, sacrificed, and preserved our nation for future generations.

The day sets out to illustrate the people of the Greatest Generation. Over the years, iconic images have been imprinted on our minds. However, they only tell a part of the story. Still, thousands more remain to be told. Spirit of '45 Day urges us to explore the history. Listen to the stories. Get involved and help preserve the memories of those who lived it.

Around the world, servicemen and women stepped up to the task in the Pacific, Europe, the Mediterranean or Africa. At home, men and women provided valuable food, parts, and labor. Everyone did their part. The youngest of them managed farm work and took on duties on the Homefront. Often, supplies of certain items were low – rubber for tires or leather for shoes, and meat, for example. And gas, too. Rationing was not uncommon.

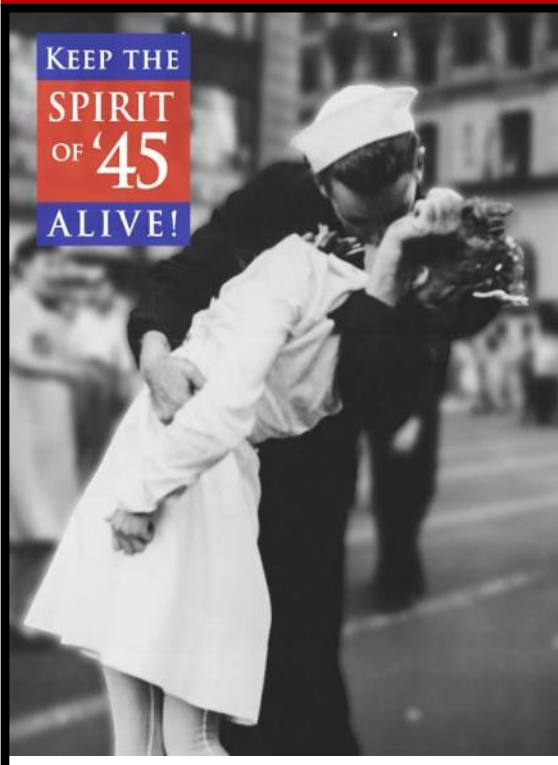
The generation innovated. They sacrificed. And roles shifted. While they did, technology advanced, too. Those motivated to do their duty often did so at personal cost. The only means of communication was the post office. Journalists filled in the blanks via radio and newspaper. And the nation paid attention!

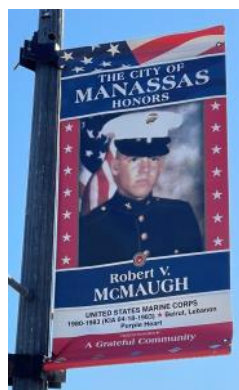

### **Jeweler’s deceptive and empty promises took advantage of servicemembers:**

Many companies say they want to serve those who serve. But some companies take advantage of our military personnel and use unlawful practices to lure them into deceptive deals. That’s why the FTC and 18 states have brought charges against Harris Jewelry for violating federal and state lending and consumer protection laws. This is also the FTC’s first case alleging violations of the Military Lending Act (MLA).

Harris sold jewelry, watches, and military-themed items to active-duty servicemembers at its stores near and sometimes on military bases. According to the FTC, Harris allegedly lured servicemembers in with shady practices, for instance, not giving them some information required to be disclosed under the MLA.

Almost all of Harris’s sales were on credit, through its in-store financing plans. Harris touted its financing plans as a way for servicemembers to raise their credit scores, and an effective way for servicemembers to get lower interest rates in the future. But Harris had no evidence to back that up. Financing a purchase does not guarantee you’ll end up with a higher credit score. And no one can guarantee that a servicemember would be able to borrow money on more favorable terms in the future by entering into a financing plan now, particularly without knowing a servicemember’s current credit score and payment history. The company also allegedly included protection plans as cost add-ons by misrepresenting the plans, or not disclosing them well enough, to servicemembers.

The settlement will stop Harris from similar practices in the future. It requires the company to give affected servicemembers refunds for purchased add-on protection plans, stop collection of servicemembers’ debt, and ask consumer reporting agencies to delete negative credit entries. Harris also must pay the states \$1,000,000 to be used for law enforcement and education efforts and complete shutting down and dissolving its operations under the states’ laws once it meets its obligations under the order.

**RULES OF THE POST 10 SOCIAL QUARTERS<sup>1</sup>  
(INCLUDES THE PATIO AND PAVILION)  
APPLIES TO ALL MEMBERS<sup>2</sup> AND GUESTS**

1. Entry to the Social Quarters (Patio and Pavilion) must only be through the main doors of the Post. Exception during official ceremonies held in the Pavilion.
2. All Members shall show their membership card to the ABC<sup>3</sup> Manager on duty prior to being served.
3. A Member is required to print legibly their name and each of their Guest(s)' name in the Register. Full legal names only – no nicknames.
4. A Member is limited to a total of 5 Guests per night.
  - a. Guests who are eligible to join the American Legion, Sons of the American Legion, or American Legion Auxiliary are restricted to two (2) visits to the Social Quarters in any calendar month. The sponsoring Member is responsible for determining membership eligibility with respect to these provisions and will inform his/her guest(s) that joining the American Legion or its recognized affiliates will determine their future visitation rights. These restrictions do not apply to a Member's immediate family.
5. A Member shall be wholly responsible for the conduct of their Guest(s). If a Member leaves Post 10 then their Guest(s) shall leave with them unless another Member in good standing signs them in.
6. A Guest will not be allowed to cash checks.
7. Guests are not allowed to purchase alcohol. The Member signing the Guest(s) into the Post is required to make all alcohol purchases for them.
8. All alcoholic beverages brought into the Post must be labeled with the member's name.
  - a. No home brew commonly known as 'moonshine' will be allowed on Post 10 property.
  - b. No beer will be allowed to be brought into the Post.
  - c. Only wine that the Post does not serve will be allowed to be brought into the Post.
  - d. Alcoholic beverages purchased or mixed in the Social Quarters may not be carried out of the building to areas in front of the Post.
9. Non-alcoholic beverages that the Post serves will not be allowed to be brought into the Post.

10. All Members and Guest(s) are expected to wear clean and presentable attire at all times.
  - a. Muscle shirts and cut-offs will not be allowed in the ABC licensed areas of Post 10 after 5:00 p.m.
  - b. At no time will any underwear be shown.
  - c. The final decision as to what constitutes proper dress rests with the on-duty ABC Manager with guidance from the House Committee.
11. While on Post 10 property parents/guardians shall maintain constant supervision of their minor (under 18 years of age) wards.
12. The hours of Post 10 Social Quarters are posted in the window at the front of the building. The ABC Manager on duty has discretion to close the facilities early due to exigent circumstances.
13. For hygienic reasons, all members and guests are required to wear foot coverings on their feet while in the Social Quarters. Bare feet are not allowed.
14. The only animals authorized to be inside Post 10 are Service Dogs.
15. Profanity and abusive/combatative behavior will not be tolerated.
16. The ABC Manager on duty shall enforce all rules and regulations. The ABC Manager has the final word until an incident report has been submitted to the Executive Board through the House and Investigative Committees.
17. During Post 10 ceremonies the Social Quarters will be closed. Occupants must either attend the Post 10 ceremony or vacate Post 10 property.
18. During hours and events where the kitchen is open no one shall bring food from an outside source into the facility. The exception would be cake and or ice cream for a special event.
19. Solicitations of any kind other than American Legion events are not allowed on Post 10 property per our By-Laws.
20. Members and Guest(s) will clean their immediate area and place trash in the proper receptacles.
21. All Members and Guest(s) are required to comply with all Virginia ABC laws.
22. With the exception of law enforcement, covered under federal and state statutes, firearms shall not be carried in the building.

Violation of any of the above may subject the Member to suspension from the Social Quarters which includes the Patio and Pavilion.

Any Member who has their Social Quarters privileges suspended shall not be allowed in the Social Quarters (including Patio and Pavilion) for the length of suspension. The only exception will be if on Legion, SAL, Rider, or Auxiliary business or attending their respective meetings. They must exit the Social Quarters immediately thereafter. Under no circumstances will a member, suspended from the Social Quarters, be allowed to consume alcohol on Post 10 premises.
