## ATTN: LEGION MEMBERSHIP DUES INFORMATION-READ

The General Membership has voted that due to increases in dues at the National and Department levels Post 10 dues will increase to \$50 a year starting with the 2025 membership year.

You can also update your profile information: address and phone number. You need your permanent membership ID number to start an account at <u>mylegion.org</u>. If you have a hand written card, you probably have a temporary number. Email me for your permanent number. Online renewals can also print out a new membership card on-line. This will show that you are paid up and I will also send out a new 2024 card once I am notified by National of your renewal.

2. By mail. If you've received your renewal request from National Headquarters, mail it to Post 10 at 9950 Cockrell Road, Manassas, VA 20110 attn: Post 10 Membership. If you haven't received a form from National Headquarters, send a check, and a note with your name, ID number, address, email and phone number.

3. In person. Stop by Post 10 and ask the bartender for a membership envelope, fill out the envelope, include your membership number and dues.

#### <u>Four Chaplains Memorial</u>

This year marks the 81st anniversary of the sinking of the United States Army Transport Dorchester and the selfless acts of four Army chaplains aboard.

The Dorchester tragically sunk on Feb. 3, 1943, while crossing the North Atlantic, transporting troops to an American base in Greenland. A German U-boat fired a torpedo that struck the Dorchester, killing 672 of the 902 officers and enlisted men, merchant seamen and civilian workers aboard. Many of those survivors owe their lives to the courage and leadership exhibited by four chaplains of different faiths, who, in sacrificing their lives, created a unique legacy of brotherhood.

As soldiers rushed to lifeboats, Reverend *George Fox* (Methodist), Jewish Rabbi *Alexander Goode*, Reverend *Clark Poling* (Dutch Reformed) and Father *John Washington* (Roman Catholic) comforted the wounded and directed others to safety. One survivor watched the chaplains distribute life jackets, and when they ran out, they removed theirs and gave them to four young men.


As the Dorchester sank, the chaplains were seen linked arm in arm, praying.



#### February is Black History Month. This year the theme is AFRICAN AMERICANS AND THE ARTS

Origins of Black History Month: The story of Black History Month begins in 1915, half a century after the Thirteenth Amendment abolished slavery in the United States. That September, the Harvard-trained historian Carter G. Woodson and the prominent minister *Jesse E. Moorland* founded the Association for the Study of Negro Life and History (ASNLH), an organization dedicated to researching and promoting achievements by Black Americans and other peoples of African descent. Known today as the Association for the Study of African American Life and History (ASALH), the group sponsored a national Negro History week in 1926, choosing the second week of February to coincide with the birthdays of

*Abraham Lincoln* and *Frederick Douglass.* The event inspired schools and communities nationwide to organize local celebrations, establish history clubs and host performances and lectures.

#### Filing a Camp Lejeune Justice Act claim? Here's how to spot and avoid scams

The Department of Justice and the Navy will never ask you to pay to file a disability claim. Want to know who will? Scammers. Keep scammers away from your personal information — and your money — while you're applying for relief. The Camp Lejeune Justice Act (CLJA) lets veterans and their families file for benefits if they were previously exposed to contaminated water at Camp Lejeune. It's free to file a claim but scammers don't want you to know that. They might call you promising to help you file your claim (for a fee) — but they're really just after your personal information and your money. Whether you've already filed a claim or plan to file one soon, you might hear from a scammer. Slow down and remember these steps to spot and avoid their tricks:

• Don't trust anyone who contacts you claiming to be from the DOJ or the Navy. Scammers try to sound real with official-sounding names and titles. Don't share any information with them. Instead, get the person's name and position, then call the Camp Lejeune Claims Unit (CLCU) at (757) 241-6020 to verify.

Only trust CLClaims@us.navy.mil — that's the Navy's official email address for the CLCU. Got a message from a different email address? It's a scam. Forward it to the CLCU.

• Never pay. If someone requests money or payment from you, it's a scam! The DOJ and the Navy won't do that.

Communicate through your attorney. If you're represented by an attorney, the DOJ and the Navy will never contact you directly about your claim. Anyone who does is a scammer. Report them to your attorney and to the CLCU right away.

Filing a CLJA claim with the Navy <u>does not</u> affect your VA disability claims. Go to navy.mil/CLJA to learn more about the Camp Lejeune Justice Act.

#### **Good To Know Info/ Consumer Protection:**

## FTC Acts to Stop FloatMe's Deceptive 'Free Money' Promises, Discriminatory Cash Advance Practices, and Baseless Claims around Algorithmic Underwriting

Order requires FloatMe to provide \$3 million for refunds, clean up advertising, halt use of dark patterns to impede cancellation, and institute a fair lending program

The Federal Trade Commission is charging online cash advance provider <u>FloatMe</u> and its co-founders with using empty promises of quick and free cash advances to entice consumers to join its service, only to fail to deliver the promised advance amounts, make it difficult to cancel, and discriminate against consumers who receive public assistance. FloatMe is also being charged with making baseless claims that cash advance limits would be increased by an algorithm or another automated system. In its complaint against FloatMe, the FTC says that the company charged consumers \$1.99 per month to join the app, and promised that consumers could access up to \$50 in cash advances instantly as part of their membership.

The FTC said, however, that consumers were only able to access \$20 in advances when they signed up and were charged a \$4 fee if they wanted to get cash "instantly," otherwise they had to wait up to three days for the promised funds. This stood in contrast to FloatMe's ads that said consumers could get "emergency funds" for free "within minutes."

When consumers contacted FloatMe to request a larger cash advance amount, the company told them that their advance limit could be increased by an algorithm over time, but the complaint charges that the algorithm did not exist. In fact, one company supervisor admitted the company's claim was "a lie" in an email to colleagues. Instead of an algorithm, the complaint points to a complicated series of steps that required manual intervention to increase a consumer's limit, which rarely happened.

## FTC Finalizes Order Requiring Old Southern Brass to Stop False Made In USA and Veteran Affiliation Claims

Following a public comment period, the FTC finalized a consent order settling charges that Florida-based EXOTOUSA LLC, (doing business as Old Southern Brass) falsely claimed that certain company products were manufactured in the U.S, and that the company was veteran-operated and donated 10 percent of its sales to military service charities.

The FTC's complaint against the company, first announced in December 2023, said that the company made numerous claims that its products were "Made in USA," but in spite of such claims, many of the company's products were wholly imported from China or contained significant imported content. The company falsely claimed various forms of affiliation with the U.S. military, including being veteran-operated and contributing a portion of proceeds to military charity groups, according to the complaint.

The final order requires the company to pay \$150,000 to the FTC, stop making false claims, and comply with specific requirements relating to future country-of-origin claims. The order also includes a monetary judgment of \$4,572,137.66, which is partially suspended based on the defendants' inability to pay the full amount.

Whether you're making funeral arrangements for a loved one in another state, or simply can't or don't want to meet with the funeral provider in person to learn about the goods and services they offer, the FTC's Funeral Rule gives you the right to get accurate information over the phone. FTC investigators recently discovered many violations of the Funeral Rule, including some providers that didn't give accurate price information over the phone and others that didn't give out any price information over the phone.


#### Sons of the American Legion, Squadron 10
