

Proposed Constitutional Amendment

ARTICLE X. Taxation and Finance.

Section 6-A. Property tax exemption for; certain veterans and their surviving spouses and; surviving spouses of soldiers killed in action <u>who died in the line of duty</u>.

BALLOT QUESTION:

Should the Constitution of Virginia be amended so that the tax exemption that is currently available to the surviving spouses of soldiers killed in action is also available to the surviving spouses of soldiers who died in the line of duty?

EXPLANATION FOR VOTERS:

Present Law

Generally, the Virginia Constitution requires that all property be taxed. It also sets out specific types of property that may be exempted from taxation. Currently, the Virginia Constitution allows the General Assembly to exempt from taxation the principal place of residence of the surviving spouse of any soldier who is determined by the U.S. Department of Defense to have been killed in action.

Proposed Amendment

The proposed amendment would expand this current tax exemption so that it is available to all surviving spouses of soldiers who are determined by the U.S. Department of Defense to have died in the line of duty, including those who have been killed in action.

A "yes" vote would allow the surviving spouse of a soldier who died in the line of duty to claim the same real property tax exemption on their principal place of residence that is currently only available to the surviving spouses of soldiers who are killed in action.

This initiative was passed by the General Assembly with the added caveat that localities could exempt themselves. A constitutional amendment, if passed, would require that all localities adhere to the regulation. The Joint Leadership Council of VSOs **strongly** supports this amendment.

Chaplain's Column





CLAIMS PREDATORS: Have you noticed advertisements from companies offering to help with the VA claims and appeals process? Do their services seem too good to be true, leaving you wondering whether to trust them? If so, you are not alone. More Veterans are getting VA health care and benefits than ever before, which also presents opportunities for scammers to commit fraud against Veterans and their families. This expansion of benefits has also attracted individuals and companies who are misleading Veterans to think it is okay to exaggerate disability symptoms in order to get higher disability ratings.

VA refers to these companies and individuals as "claims predators"; these claims predators are not accredited by VA. They are known to aggressively prey on Veterans' benefits through various channels such as mail, telephone, TV, or online platforms. They try to take advantage of Veterans and their beneficiaries by using high-pressure tactics, sharing misleading information and making false promises to convince Veterans to sign up for their services. These services usually come at a high cost to Veterans, with little to no actual benefit.

To avoid falling victim to claims predators, Veterans and their loved ones must be cautious when seeking assistance with their VA claims and appeals. It's crucial to always verify the legitimacy of the individual or company before providing any information. VA strongly advises against working with unaccredited companies and individuals. Instead, VA recommends seeking help from VA accredited claims agents, attorneys and Veterans Service Organizations (VSOs). These individuals and organizations are recognized by VA, having established the good character and competence necessary to navigate the VA benefits system, ensuring Veterans and their beneficiaries receive the benefits they have rightfully earned.

It's important that Veterans and their families know they should never pay a fee to file an initial claim for benefits. In fact, it's unlawful for anyone to charge a fee for preparing an initial claim. Only VA accredited attorneys. claims agents and VSO representatives can lawfully assist Veterans with their initial benefits claims. Only accredited attorneys and claims agents may charge a fee to:

- Consult or advise VA claimants seeking review of or to appeal their claims.
- Collect evidence for a supplemental claim or an appeal.
- Prepare and file a supplemental claim.
- Submit requests for higher level review.

Submit an appeal to the Board of Veterans Appeals.

If you suspect a representative acted unlawfully or unethically while assisting you in filing a VA benefits claim, file a report and learn more at VSAFE.gov or call 1-833-38V-SAFE (1-833-388-7233), a new government-wide website and call center designed to protect Veterans, service members, and their families from fraud and scams. These tools will inform Veterans and their families about common fraud schemes and help protect themselves, and provide an outlet for reporting and further assistance. [Source: VA NEWS]

The Post had the honor of LtCol Larry Naylor, US Army ret, as the guest speaker for the POW/MIA Recognition Day Ceremony. LtCol Navlor detailed his hands on experience as part of the Joint POW/MIA Accounting Command (JPAC) searching for and recovery of Americans missing as a result of our nation's past wars. He has spent time in Cambodia, Laos, and Vietnam on the mission. His detailed accounting of the painstaking efforts by JPAC was educational, informative, and enlightening to all that attended the ceremony. LtCol Naylor detailed the process of the recovery efforts by the US beginning with the JPAC historians and analysts who gather information from records, archives, interviews and other sources. The researchers create a 'loss incident case file' for each unaccounted for service member. The file includes historical background, military medical and personnel records, official correspondence, maps, photos, and other relevant evidence. Before a team goes out the US must be granted permission to proceed by the host country. JPAC sends out an investigative team to these potential sites. Each team consists of a team leader, analyst, linguist, medic and in some cases an anthropologist, explosive ordnance disposal technician, and a life support technician. The teams survey the sites and searches for new leads that may help at this site as well as other sites. The team then determines if excavation is warranted. The excavation team consists of the above plus a forensic photographer and mortuary affairs technician. The recovery team members must be in top physical condition to reach sites in remote areas such as dense jungles, mountains, and rappelling down cliffs. These missions may employ up to 100 local workers. Recovery sites can be as large as a football field in cases where there were aircraft crashes. The sites are sectioned off in grids approximately 4' x 4' - the ground is dug pail by pail and the dirt is sifted thru 'chicken wire' for any remains. Any remains found are placed in aluminum transfer cases and draped with a US flag. An arrival ceremony is held at the Central Identification Lab, Hawaii. Here the anthropologists and forensic dentists begin their work to identify the remains. The entire process may take years to complete. Once a case is completed. The identified American is transferred to the appropriate service mortuary office. Military members from these offices then notify families personally of the identification. On behalf of Post 10 we thank LtCol Naylor for his time and effort at the ceremony and for his untiring effort at JPAC to ensure a full accounting of our MIAs. We also thank Mrs. *Leatrice Naylor*, Army Veteran, for her attendance and help with posting the Army flag during the ceremony.
