#### KILLED IN BOMBING OF U.S. EMBASSY

On April 18, 1983, the US Embassy in Beirut, Lebanon, was partially destroyed by a suicide bombing that killed 63 people. It was the deadliest attack on a U.S. diplomatic mission up to that time and was considered the beginning of Islamist attacks on U.S. targets.



**LCpl Robert Vincent McMaugh** was killed in the attack. He was a 1980 graduate of Osbourn High School and joined the Marines a few months later. He volunteered to become a Marine Security Guard (MSG), and after training he was sent to Beirut. **Robert** was standing Post 1, front entrance to the Embassy, and was instantly killed by the explosion. He was posthumously promoted to the rank of Corporal.

*Cpl McMaugh* is buried at Arlington National Cemetery. In 2023 a ceremony was held on MCB-Q dedicating the <u>McMaugh Hall</u> in memory of *Cpl McMaugh*.

As you are aware our Post is named for *Cpl Robert V. McMaugh*.

You can now renew for up to 3 years online. Go to mylegion.org, click the renew tab and put in your member number and you should be able to extend your membership at the current membership price for 3 years. If you have any questions, please feel free to contact me.

There are several ways to renew your American Legion membership:

- 1. Online at <a href="www.mylegion.org">www.mylegion.org</a>. You can use a credit card online and set-up automatic yearly renewal with your credit card. You can also update your profile information: address and phone number. You need your permanent membership ID number to start an account at <a href="mylegion.org">mylegion.org</a>. If you have a hand written card, you probably have a temporary number. Email me for your permanent number. Online renewals can also print out a new membership card on-line. This will show that you are paid up and I will also send out a new 2024 card once I am notified by National of your renewal.
- 2. By mail. If you've received your renewal request from National Headquarters, mail it to Post 10 at 9950 Cockrell Road, Manassas, VA 20110 attn: Post 10 Membership. If you haven't received a form from National Headquarters, send a check, and a note with your name, ID number, address, email and phone number.
- 3. In person. Stop by Post 10 and ask the bartender for a membership envelope, **fill out the envelope**, include your membership number and dues. Current Legion dues are \$50.00. Provide your address, email, and phone number. It's important to be able to contact you. Your information is stored in a protected database, accessible only to Post officers with a need to know. If you have an email address and can receive the newsletter electronically it will save the Post money. Please feel free to email me with any questions/concerns about your membership. 

#### **WOMEN IN THE MILITARY**


*Margaret Cochran Corbin* - 1751-1800: A hero of the American Revolution, *Margaret Cochran Corbin* was the first woman to receive a military pension. The hardships of *Corbin's* young life inspired the courage and resilience that would serve her well during the Revolution. Born in Franklin County, PA on November 12, 1751, she was orphaned at age five, when her father was killed during an Indian raid and her mother was taken captive. She and her brother were adopted and raised by an uncle.


In 1772, at age 21, she married *John Corbin*, who joined the PA military 3 years later. Instead of staying home, *Corbin* left with her husband for war, becoming a camp follower who earned money cooking and doing laundry for soldiers. She also helped take care of the sick and wounded. On November 16, 1776, *Corbin* dressed as a man and joined her husband in the Battle of Fort Washington on Manhattan Island. There, she helped him load his cannon, and when he was killed, she quickly and heroically took over firing the cannon against the British. Other soldiers commented on "*Captain Molly's*" steady aim and sure-shot. She, too, was hit by enemy fire, which nearly severed her left arm and severely wounded her jaw and left breast. She was unable to use her left arm for the rest of her life. The British eventually won this battle, with *Corbin* among the prisoners of war who were paroled and released back to the care of Revolutionary hospitals. After her recovery, *Corbin* joined the Invalid Regiment at West Point, where she aided the wounded until she was formally discharged in 1783. Then, on July 6, 1779, the Continental Congress, in recognition of her brave service, awarded her with a lifelong pension equivalent to half that of male combatants. Congress also gave her a suit of clothes to replace the ones ruined during the conflict.

In 1782, *Corbin* married a wounded soldier who died a year later. Gruff and unfeminine, *Corbin* made few friends among the women of her time, instead feeling more at home smoking and conversing with other soldiers.

*Corbin* died near West Point before reaching her 50th birthday. In 1926, her remains were moved from a grave along the Hudson River to West Point, where she was buried with full military honors. A plaque at Fort Tryon Park in Manhattan, hails her "as the first woman to take a soldier's part in the War for Liberty."

VETERANS AFFAIRS FRAUD ALERT: Durable Medical Equipment (DME) fraud involves billing for equipment that is medically unnecessary or was never provided to patients. Examples of DME include orthotics, catheters, oxygen and dialysis equipment, glucose monitoring systems, wheelchairs and other mobility aids, or other medical devices used repeatedly for long periods. Veterans and VA personnel can help by identifying and reporting these scams to the VA OIG. VA personnel should report events such as payments offered to induce patient referrals for DME or attempts by medical suppliers to gain authorization for DME not ordered by the veteran's healthcare providers within VA or through community care. Veterans can assist by reporting offers of free or low-cost DME from solicitors claiming VA affiliation or receipt of medical devices by mail that were not prescribed by a VA-assigned physician. Deficiencies in Managing Supply, Equipment, and Implant Inventory at the Michael E. DeBakey VA Medical Center in Houston, Texas: In 2023, the VA OIG received several allegations that raised concerns about the management of supplies and equipment and workplace culture at the Michael E. DeBakey VA Medical Center in Houston, Texas. The OIG initiated this review to evaluate whether the Houston facility supply chain management staff established and maintained inventory controls in accordance with VA policy. The OIG identified deficiencies in managing supplies, equipment, and implant inventory at the Houston facility. Supply chain management staff did not ensure accurate recording and accountability of expendable supplies, nonexpendable equipment, and implants in the inventory management systems, as mandated by VHA policy. These deficiencies stemmed from inadequate oversight and failure to follow inventory procedures, risking the loss of supplies or use of expired products for patient care. The OIG made 10 recommendations to the Houston medical facility director: six recommendations to improve inventory management oversight and compliance with inventory procedures and four recommendations to improve implant management.

<u>TOP SCAMS of 2024:</u> Did you or someone you know report a scam to the FTC in 2024? Thank you! Those reports help the FTC bring enforcement cases and educate people about scams. Let's jump into the top 2024 scams. The headline is this: even though the number of fraud reports is roughly the same as last year, more people lost a lot more money to fraud. One in three people who reported fraud said they lost money (up from one in four last year), adding up to \$12.5 billion (up \$2.5 billion from 2023). People lost over \$3 billion to scams that started online, compared to approximately \$1.9 billion lost to more "traditional" contact methods like calls, texts, or emails. However, people lost more money per person (a median of \$1,500) when they interacted with scammers on the phone. And, once again, imposter scams topped the list of scams reported. Here are some other things to know:

- The biggest scam losses happened by bank transfer or payment. Among all payment methods, people reported losing more money through a bank transfer or payment (\$2 billion), followed by cryptocurrency at \$1.4 billion.
- **Investment scams led to big losses.** A majority (79%) of people who reported an investment-related scam lost money, with a median loss of over \$9,000. The \$5.7 billion losses in this category are up about \$1 billion from last year.
- People reported losing money more often when contacted through social media. Most people (70%) reported a loss when contacted on a social media platform and lost more money overall (\$1.9 billion).
- **Job scams and fake employment agency losses jumped** a lot. Between 2020-2024, reports nearly tripled and losses grew from \$90 million to \$501 million.

**Younger people lost money more often.** People aged 20-29 reported losing money more often than people 70+. But when older adults lost money, they lost far more than any other age group.
