You can now renew for up to 3 years online. Go to mylegion.org, click the renew tab and put in your member number and you should be able to extend your membership at the current membership price for 3 years. If you have any questions, please feel free to contact me.

There are several ways to renew your American Legion membership:

1. Online at <u>www.mylegion.org</u>. You can use a credit card online and set-up automatic yearly renewal with your credit card. You can also update your profile information: address and phone number. You need your permanent membership ID number to start an account at <u>mylegion.org</u>. If you have a hand written card, you probably have a temporary number. Email me for your permanent number. Online renewals can also print out a new membership card on-line. This will show that you are paid up and I will also send out a new 2024 card once I am notified by National of your renewal.

2. By mail. If you've received your renewal request from National Headquarters, mail it to Post 10 at 9950 Cockrell Road, Manassas, VA 20110 attn: Post 10 Membership. If you haven't received a form from National Headquarters, send a check, and a note with your name, ID number, address, email and phone number.

3. In person. Stop by Post 10 and ask the bartender for a membership envelope, **fill out the envelope**, include your membership number and dues. Current Legion dues are \$50.00. Provide your address, email, and phone number. It's important to be able to contact you. Your information is stored in a protected database, accessible only to Post officers with a need to know. If you have an email address and can receive the newsletter electronically it will save the Post money. Please feel free to email me with any questions/concerns about your membership. The POPPY and MEMORIAL DAY

In the battlefields of Europe, the common red field poppy was one of the first plants to reappear. Its seeds scattered in the wind and sat dormant in the ground, only germinating when the ground was disturbed—as it was by the very brutal fighting of World War 1. *John McCrae*, a Canadian soldier and physician, witnessed the war first hand and was inspired to write the now-famous poem "In Flanders Fields" in 1915. He saw the poppies scattered throughout the battlefield surrounding his artillery position in Belgium.

In November 1918, days before the official end of the war, an American professor named *Moina Michael* wrote her own poem, "We Shall Keep the Faith," which was inspired by *McCrae's* "In Flanders Fields." She mentioned wearing the "poppy red" to honor the dead, and with that, the tradition of adorning one's clothing with a single red poppy in remembrance of those killed in the Great War. *Moina* became known as "The Poppy Lady."

The wearing of the poppy was traditionally done on Memorial Day in the U.S., but the symbolism has evolved to encompass all Veterans living and deceased, so poppies may be worn on Veterans Day as well. Not long after the custom began, it was adopted by other Allied nations, including Canada, Australia, New Zealand, and the UK. In these countries, the poppy is worn on Remembrance Day (Nov. 11th).

Today, poppies are not only a symbol of loss of life, but also of recovery and new life, especially in support of the Veterans who survived the war but suffered from physical and psychological injuries long after it ended.

In Flanders fields.

Take up our quarrel with the foe: To you from failing hands we throw The torch; be yours to hold it high. If ye break faith with us who die We shall not sleep, though poppies grow







MEMORIAL DAY, Monday, 26 MAY 2025

WHAT'S THE DIFFERENCE BETWEEN MEMORIAL DAY AND VETERANS DAY?

On both Memorial Day and Veterans Day, it's customary to spend time remembering and honoring the countless veterans who have served the United States throughout the country's history. However, there is a distinction between the two holidays:

- **Memorial Day** commemorates the men and women who **died** while in the military service of their country, particularly those who died in battle or as a result of wounds sustained in battle. In other words, the purpose of Memorial Day is to memorialize the veterans who made the **ultimate sacrifice** for their country. We spend time remembering those who lost their lives and could not come home, reflecting on their service and why we have the luxury and freedom that we enjoy today. We might consider how we can support and safeguard their grieving families and loved ones who are left behind.
- Veterans Day is the day set aside to thank and honor ALL who served—in wartime or peacetime—regardless of whether they died or survived. Veterans Day is always observed officially on November 11, regardless of the day of the week on which it falls.

For those who have lost loved ones in the military, hearing "*Happy Memorial Day*" can be unsettling. Many veterans have expressed their displeasure with the phrase, deeming it inappropriate for the occasion. While Veterans Day is a time to honor all those who have served in the military, Memorial Day is meant to pay tribute to those military personnel who *died while serving*.

The holiday began three years after the Civil War ended and was known as Decoration Day, a time to decorate the graves of fallen soldiers with flowers. The designated date was 30 May, the Uniform Monday Holiday Act (28 JUN 1968) took effect, moving Memorial Day to the last Monday in May.

In 2015, Marine Corps veteran *Jennie Haskamp* wrote a piece for <u>The Washington Post</u> in which she shared her frustration with the sentiment of "Happy Memorial Day" and the holiday's transformation into "grilled meat, super-duper discounts, a day off work, beer, potato salad and porches draped in bunting." She said it should be more than that. Others have argued that using Memorial Day as an opportunity to celebrate with loved ones and embrace the joy that life has to offer is a fitting way to honor those who died in service of our country.

Those who seek to remind people of the more somber meaning of Memorial Day have advocated for Congress to change the date of the holiday back to 30 May, instead of making it part of a three-day weekend of leisure. These efforts have not been successful, Congress established **"The National Moment of Remembrance"** in 2000, asking Americans to pause for a minute of silence and reflection in honor of those who died in military service at **3 p.m. local time on Memorial Day**.

In *Haskamp's* Washington Post piece, she noted that a friend reminded her how many people use Memorial Day to "pause and remember the men and women who paid the price of our freedom, and then go on about enjoying those freedoms." But she believes not enough people commemorate the occasion in this way. "Not enough people pause. Not enough people remember," she wrote, "I hope you enjoy your weekend — but I hope you pause to remember, too."


Please take this time with your family and friends to enjoy your lives and the beauty that has been created that you and your family can have at your fingertips.

Virginia Post 10 opening up its doors to the community for its first BBQ Showdown, with the main goal to raise fundraise for the Veterans & Children Foundation.

A Virginia American Legion post is taking a unique approach to raise money for one of the Legion's most critical funds. And it's bringing its community in to assist the effort. This weekend, Robert V. McMaugh Memorial Post 10 in Manassas will stage its inaugural BBQ Showdown. Proceeds from the event will benefit The American Legion Veterans & Children Foundation (VCF), as well as two local charities.

The idea for the event came from Post 10 Commander *Stanley Moore* after attending the Legion's national convention and learning about the 1919 Society, which celebrates those who have made a substantial impact in the lives of military families and veterans through financial gifts to the VCF.

"I've been fascinated by the 1919 Society and the Veterans & Children Foundation and all that goes into it," *Moore* said. "We wanted to do a barbecue competition, and I figured this would be the perfect way to get money and donate it to the foundation from the post. And get the community involved."

Moore said the actual idea of using a barbecue competition came from Sons of The American Legion Squadron Commander *Dan Frye*. "When I was looking for something to raise money with for the VCF, *Dan Frye* mentioned the barbecue," *Moore* said. "That's where I got the idea, from him. And he has been extremely helpful and instrumental in getting it off the ground."

The competition will feature both professional pitmasters and amateur grillers showcasing their skills in a variety of categories: ribs, chicken and brisket, as well as a People's Choice pulled pork winner being chosen by those in attendance.

Judges for other three categories include Department of Virginia Commander *Eugene Malinowski*, Sons of The American Legion Detachment of Virginia Commander *Kevin Chaplin* and *Ian Lovejoy*, a member of the Virginia House of Delegates.

There also will be live music from local bands, as well as games and activities for children and adults, including horseshoes, inflatables and carnival-style games. "The community is where we make our biggest impact, especially as a post," said *Moore* in explaining why the event is open to the public. "When you get the community involved, it makes it easier to get them to support our veterans. This brings awareness. We're an organization that's there to help. It makes people see us in a different light."

Moore also said it was important to make the event a Legion Family effort. Auxiliary Unit 10 has chosen local nonprofit Serve Our Willing Warriors as its charity for the event, while SAL Squadron 10 will donate its share of the proceeds to Final Salute. "That way we give them a little bit of ownership (of the event)," *Moore* said. "We are a family. The more we can do together, the more we can get done."

Moore said the goal is to continue the event every year, with the purpose being raising money mainly for the VCF. It's the component of the fund that provides money for the Legion's Temporary Financial Assistance (TFA) grant program that stands out to Moore. TFA provides cash grants to minor children of current active-duty or American Legion members to help meet the cost of shelter, food, utilities and health expenses.

"Really, kids are our future, and that's what I've been concentrating on this year: events and programs like Junior ROTC, Boys State," he said. "If we don't have a good foundation for the kids to grow up in and become leaders in their own right, it doesn't look good for us.

"Give them that base. Give them the knowledge that we're here for them and we're behind them. It will make them better people and better citizens in the future."

Safety Message for All Riders

As riding season ramps up, we remind all motorcyclists to prioritize safety before hitting the road:

- Perform your yearly maintenance: Change your oil and filter, check your brakes, and inspect your battery and coolant levels to ensure your bike is in top condition.
- Confirm your tires are in good shape: Look for proper tread depth, check for cracks or signs of wear, and make sure tire pressure is at the recommended level. Remember, tires older than 5-7 years or showing any cracking should be replaced immediately.
- Ensure your state inspection sticker is valid: Riding with an expired inspection sticker can result in fines and, more importantly, may mean your bike isn't as safe as it should be.

Inspect your protective riding gear: Make sure your helmet, gloves, jacket, and other gear are in good repair. Replace any equipment that shows signs of wear, UV damage, or compromised protection. Quality gear is your first line of defense in the event of an accident.

Stay safe, ride smart, and honor the spirit of service that defines the American Legion Riders.
