8. **EVENT VENDING DETAILS AND REGULATIONS:** Event Vending Details and Regulations must be signed and attached to this registration form. **EVENT VENDING DETAILS & REGULATIONS**

1. **OFF-SITE COOKING (RESTAURANT ONLY):** For restaurants permitted to cook off site, you must plan to arrive to the Competition site no later than 10:00 AM the day of the event and be in place with additional vehicles moved from the event site by 11:00 AM. Set Up on Saturday, April 11th begins as early as 4:00 PM. The event site is open to the public at 12:00 PM on April 12th. Please be ready to serve by 2:00 PM.

2. **ON SITE COOKING:** BBQ Teams are welcome to set up as early as Saturday, April 11h from 4:00 PM. You may cook on-site overnight. All People's Choice Teams must be in place with additional vehicles moved from the event site by 10:00 AM on April 12th. The event site is open to the public at 12:00 PM. Please be ready to serve by 2:00 PM.

3. **PRODUCT:** BYOM Bring Your Own Meat

4. **AWARDS:** Ceremony will begin between 4-4:30 PM. There will be first, second and third place winners for Peoples choice 1st Place Prize will receive a cash prize and Trophy with 2<sup>nd</sup> and 3<sup>rd</sup> receiving a trophy for bragging rights

5. **SAMPLES:** Samples should only be given to **paying** event attendees with Red or Blue colored wristbands. Expect to serve 400 so serve small portions or bring lots of meat.

6. **INSURANCE:** If the Applicant does **not** have a Certificate of Insurance in the amount of \$1,000,000 naming American Legion as the Additional Insured and the Certificate Holder, the waiver in Item #7 must be completed.

In the event the liability of the User shall arise by reason of the sole negligence of the County and/or the sole negligence of County's employees, agents, or servants, then and only then, User shall not be liable.
